This fall (2025) we will begin offering an annual stipend to each JROTC unit of \$500 to \$1000 (exact amount to be determined by JROTC Stipend Committee) to be used for miscellaneous supplies, special event support or other needs as determined by each Unit.

The "Big Ask" of you, our members, is to consider donating to the JROTC Stipend Fund to raise the \$5,000 to \$10,000 needed each year. Many of you have donated to the Scholarship Fund for our college student applicants. The great news is that the Anna Johnson Endowment fund now has a balance of over \$100,000 even though we have given away \$4,000-\$6,000 per year. It just continues to grow and is fully capable of supporting 6-8 college scholarships for a number of years. ### **LEGISLATIVE AFFAIRS**

While this input is for the July issue of our award-winning newsletter, the articles are from the month prior as none of us know what the future will hold. As a volunteer at your National Naval Aviation Museum (along with our esteemed

President and former IKE Shipmate Ken Pyle) I spend a couple of Sundays a month giving tours of the museum. In our newest building outside of the main building (called Hangar Bay One) hangs a Navy R-4D which in civilian service was a DC-3 and in Army a C-47. The one we have is equipped with skis for landing on snow and ice. These were used to support scientific expeditions in Antarctica in the 1950's. On October 31st, 1956, history was made in this aircraft when LCDR Gus Shinn, USN along with crew and passengers landed the aircraft at the South Pole. This marked the first visit by man in over 40 years and the very first by airplane. Until recently the Commander lived in Pensacola and was 102 years old when he passed.

### MOAA President: DoD Budget Boost Brings 'Opportunity' Amid Concerning Federal Cuts

The first-ever proposed trillion-dollar defense budget offers "a lot of opportunity to do great things for quality of life for our military members," MOAA President and CEO Lt. Gen. Brian T. Kelly, USAF (Ret), said in a recent radio interview with Federal News Network, a discussion which also touched on MOAA priorities regarding veterans and military spouses in the face of proposed federal spending cuts.

Kelly told <u>The Federal Drive</u> host Terry Gerton that the budget plan "has some improvements to housing, <u>to give full allowance for housing</u> – we want to make sure that stays in there. That was something MOAA has been asking for and supporting for a number of years."


"It will all come down to what happens with <u>reconciliation</u>," Kelly added in the interview, which aired May 15. "So we'll be paying a lot of attention and giving our thoughts, and providing help and support when we can."

### 'Efficiencies' and Earned Benefits

While DoD and VA budgets may not feel quite the impact of federal efficiency measures as other departments, Kelly stressed that service-earned benefits weren't immune from collateral damage.

"We certainly don't want to see those efficiencies, which we're appreciative of, and those savings, which we're supportive of, happen on the backs of those earned benefits for our military members, their families, our veterans," Kelly said.

The Federal News Network interview was recorded the day after Kelly and other MOAA leaders met with VA Secretary Doug Collins; Kelly praised Collins' "focus on veterans" and noted the VA-benefit improvements MOAA and other veterans







groups have championed in recent years, including generational toxic-exposure reform and better education benefits.

"A lot of work was done [to make] great strides forward for the veteran community," Kelly said, "and you certainly wouldn't want to see any of those things reversed or impacted as the result of hasty cuts or reductions."

### **Federal Hiring in Focus**

Asked about recent federal staffing cuts, Kelly stressed the need to continue programs "purposely put in place in the past by administrations, including the first Trump administration, that recognized that employment for our veterans is a key thing. It's one of the things that they earned."

"The same thing for our spouses: Recognizing that military spouses have a very high unemployment rate – 21%, way higher than the national average – it's tough for them. Giving military spouses an opportunity to be employed helps us retain, helps us attract and recruit, members to the military."

While these programs may sometimes be "at odds" with staffing reductions, Kelly highlighted "an inherent strategic opportunity to keep [veterans and military spouses] at higher rates."

## Senate Hearing Spotlights MOAA-Backed Bill to Support Veteran Caregivers

A recent Senate Veterans' Affairs Committee hearing highlighted growing interest in a MOAA-supported proposal designed to provide critical transitional support for military caregivers.

The committee reviewed and discussed the Veteran Caregiver Reeducation, Reemployment, and Retirement (3R) Act alongside other legislation in a May 21 meeting, which featured testimony from the VA and various veterans service organizations (VSOs), including MOAA.

"Despite their vital role, caregivers face significant financial, professional, and emotional burdens," MOAA told the committee in written testimony. "Many forgo careers, retirement savings, and personal well-being to provide care."

The 3R Act addresses key concerns raised by caregivers transitioning out of the VA's <u>Program of Comprehensive Assistance for Family Caregivers</u> (PCAFC), including job reentry, retirement planning, health care access, and financial stability. These caregivers often sacrifice income, career advancement, and long-term financial security to care for their loved ones ... and are met with significant gaps in support.

The bill proposes a comprehensive package of support tools, such as job training assistance, counseling, continued health care coverage, and help with professional relicensing costs, all aimed at easing the shift into post-caregiving life.

#### What's Next

With congressional interest building, the 3R Act represents an opportunity to ensure caregivers are recognized and supported long after their caregiving duties conclude. As this legislation progresses, MOAA continues to work closely with lawmakers to ensure the bill's provisions reflect the real needs of military families.

"By offering education, employment, and retirement opportunities, the act would empower caregivers to achieve financial security while potentially reducing the federal government's long-term economic burden by decreasing their future reliance on government assistance programs," MOAA told the committee in written testimony.

## Space A-101: How (and Where and When) to register for Travel

Planning an adventure this summer and considering space-available (or Space-A) travel to save on the trip? You're not alone: A recent MOAA webinar on the basics of this earned benefit topped out our virtual platform, with more than 1,000 eager travelers looking for expert guidance.

The May 28 webinar – hosted by Stephanie Montague, founder and president of the military travel-focused <u>Poppin' Smoke</u> website – served as an introduction to the benefit. One of the many topics tackled: How to sign up (or register) for the benefit.

### When to Register

Travelers have priority within their Space-A category based on when they sign up to travel, explained Montague, who is married to an Army retiree.


"If my husband signed us up for Space-A travel 50 days ago, even if an active duty family signed up yesterday, they're still a higher priority than we are," she said. "On the other hand, if other <u>Category 6 passengers</u> signed up two weeks ago, we're higher priority than them if we're competing for the same flight."

Retirees can sign up at any point, with their registration valid for up to 60 days. Those on active duty can only sign up during their leave, and their registration can last through the end of their leave period.

### Where to Register

Do you have multiple options for departure points? Sign up for all of them, Montague said.







"There's no downside to signing up for a terminal and never trying to fly from there. You can sign up for every terminal in the world, if you want to," she said.

If you're living on the East Coast of the U.S. and planning a European vacation, for example, don't limit your selections to the nearest airport or installation – you can register at locations from Charleston, S.C., to Joint Base McGuire-Dix-Lakehurst, N.J., to keep all your options open.

### **How to Register**

Montague outlined multiple options:

- **In person:** Perfect for those who live near a terminal. Be sure you get printed confirmation of the registration.
- Online: The <u>Air Mobility Command sign-up form</u> allows travelers to register virtually, but only at one terminal per form submission.
- Email: Montague recommends this method, where travelers can sign up at multiple terminals at the same time. Air Mobility Command offers an email directory of its passenger terminals (click here and scroll down); send the required information to the right addresses, and your sent email becomes your proof of registration.

"Do not sign up more than once, because your most recent sign-up is the one that's applicable," Montague said. "If you sign up a month ago and you think ... 'I want to be sure that they got it,' and you send it again, you've just lost your place in the virtual line."

### More to Know

Check out the full webinar for details from Montague on:

- Eligibility: A breakdown of the Space-A categories, and how they factor into geographic restrictions and travelpriority levels.

## Beyond SGLI: Do You Have a Life Insurance Plan for After Service?

While serving in the military, you have access to low-cost life insurance through the Servicemembers' Group Life Insurance (SGLI) program. You can get the maximum coverage of \$500,000 for \$31 a month, regardless of age or health. And premiums are set to drop to \$26 a month starting July 1, 2025.

But SGLI coverage typically expires 120 days following separation from service, with a few exceptions. So do you have a plan for after you leave the military?

"If the servicemember has certain conditions or a disability that prevents them from maintaining gainful employment, they can apply for a free extension of their SGLI for up to two years following separation from service," said Timothy Sirhal, executive director of insurance service for the VA.

Some families need life insurance after SGLI ends. There are several options, including the VA's Veterans' Group Life Insurance (VGLI). But the rules and costs differ from SGLI.

You have one year and 120 days after separating from service to apply for VGLI. If you apply within the first 240 days, you don't have to answer any health questions. But if you apply beyond that period up to the maximum time frame, you must answer health questions and meet requirements for approval, according to Sirhal.

VGLI premiums increase in five-year increments and rise significantly as you get older.

You can receive the same level of VGLI coverage as you had for SGLI. You can also purchase up to \$25,000 more after a year and then every five years, up to the current maximum coverage of \$500,000, Sirhal said.

If you're healthy, you might pay a lot less for a private life insurance policy. Under current VGLI rates, a healthy, nonsmoking 42-year-old man would pay \$151,560 for \$500,000 of VGLI over 30 years, said Lt. Col. Joshua Andrews, USAF (Ret), CFP®, advice director for USAA. For this servicemember, comparing VGLI costs to private policies might be beneficial.

But if a servicemember has preexisting health conditions, you might have to pay more for the private coverage or simply not qualify at all. In this case, VGLI might be a better option if you apply within the first 240 days.

Lt. Col. Amy King, USA (Ret), CFP®, the founder of Maryland-based <u>Instar Financial Planning</u>, said VGLI can be helpful for those with health issues, especially if there's a need for extra short-term coverage.

"I've run across clients who need coverage for three to five years to pay off a mortgage, but they probably couldn't get through underwriting [for private insurance] without it being expensive," she said.

Consider assessing your life insurance needs, and shop around for a private policy before you leave the military. Then compare those costs to VGLI.

# 'Task Scams': How to Steer Clear of This Growing Type of Fraud

So-called "task scams" – promising compensation for low-level online jobs but instead swindling victims out of personal data, or worse – have exploded in recent months, from less than 500 such scams reported to the Federal Trade Commission (FTC) in all of 2021 to 20,000 reports in the first six months of 2024.

And unlike other types of job scams, they target individuals of all ages in all financial circumstances. Instead of a 40-hour workweek, they offer pay for repetitive tasks like rating videos





or applications, downloading or testing software, or similar easy-to-accomplish online duties. Some might even track the victim's "earnings" in an app as the initial jobs are accomplished.

Then, things turn south.

"At some point, the app or online platform will ask you to deposit your own money — usually in crypto — to complete your next set of tasks and to get your supposed (fake) earnings out of the app," according to an FTC consumer alert. "But if you make the deposit, not only is your real money is gone, you'll never get those fake earnings."

There are variations on the theme: In some instances, the scammers may ask for bank account information as a way to transfer earnings, but instead sell or use those details to steal the victim's identity. Whatever the endgame, the scammers' work has paid off: Job scams (including task scams) cost a reported \$41 million in cryptocurrency losses alone in the first six months of 2024, up from \$21 million in all of 2023, per the FTC.

Think servicemembers and veterans are safe? Think again: Business- and job-related scams cost the "military community" – those in uniform and their family members, along with retirees and veterans – \$38.4 million in 2024, up from \$26.4 million the previous year. Victims lost \$2,800 on average in 2024, up from \$2,600 in 2023.

### **Stopping Task Scams**

Along with traditional anti-scam advice <u>available from MOAA</u> and <u>other outlets</u>, keep the following tips in mind when combating task scams:

- Platform is key. Real job offers won't come unsolicited via text messages, emails, or apps like WhatsApp. It's a reason to stop right from the start.
- Don't pay to get paid. This technique can be found in other scams, such as <u>multilevel marketing schemes</u>, and should be an immediate red flag.
- Follow the money (or don't). Watch for promises of payments in cryptocurrency, and steer clear of any offer that involves gift cards. These payment methods can be all but untraceable, making it more difficult to recover losses after a scam.

If you've been a victim of a task scam or suspect you're being targeted, <u>file a report with the FTC</u>.



### PMOAA BOARD OF DIRECTORS MEETING June 24, 2025

The meeting was called to order by President Ken Pyle at 1602 at the El Patron Mexican Grill. Board members present were: RADM Joan Engel, CAPT Meredith Yeager, LtCol Bob Nelson, CDR Susan Ulloa, LTC Karen Vinson-VanHouter, MAJ Molly Werner, Maj Charley Booton, CPT Dean Kirschner, Surviving Spouse Chair Mrs. Judy Dickson, and Beacon Editor Jean Booton. CAPT Sue Varenholt was excused.

May 2025 BOD Minutes – Mrs. Dickson requested a correction to the May minutes. She noted that the correct web address for submission of cookbook recipes or to pre-order a cookbook is <a href="mailto:cookbook@pmoaa.org">cookbook@pmoaa.org</a>. All members present approved the minutes as corrected.

Treasurer Report – Bank accounts balance for this month: Total Bank Accounts - \$26,779.50; Total Assets Accounts - \$102,192.24. LtCol Nelson noted that the balance increase was due to a generous contribution from a member to be awarded to two scholarship recipients pursuing a degree in a medical field. The account will be minus that amount following the Scholarship Banquet in July. The President called for approval of the Treasurer's report. Concurrence was unanimous. As website manager, LtCol Nelson related that members may have been unable to access MOAA/PMOAA website the past few weeks and mentioned that software was needed to override the glitch.

### **REPORTS**

1st Vice President – LTC Vinson-VanHouter verified the speaker line-up at the member meetings for the remainder of the year. She stated she had 2-3 guest speakers for the first months of next year and requested suggestions from the Board for additional recommendations. Several names were proposed and LTC Vinson-VanHouter will follow up on those.

**2<sup>nd</sup> Vice President** Membership – MAJ Werner explained the purpose of the Near Real Time (NRT) report to the Board which is a list of MOAA members who reside in the local area but do not belong to the local Chapter. She noted that there were several duplications and when removed, the list left a total of thirty-three (33) potential PMOAA members. Efforts will be made to recruit each of them for membership in PMOAA. Total membership this month remains at 132.

**Survivor Assistance –** Mrs. Dickson attended the funeral services for Helen Peach, member spouse who passed away earlier this month. While there, she expressed condolences from PMOAA to Helen's husband, retired Navy CDR Ellis Peach, and offered assistance with information on navigating the legal and domestic issues associated with the death of a spouse.

Cookbook Project – the project continues to move forward. Over seventy (70) recipes have been submitted to date. The goal is to have approximately one hundred (100) recipes





available before the book order goes to print. Mrs. Dickson continues to receive volunteers eager to assist on the project. Members are reminded to submit their recipes online at <a href="mailto:cookbook@pmoaa.org">cookbook@pmoaa.org</a>, or by mail to the PMOAA address using the recipe form which will be available at the next few member meetings. Cookbooks may also be pre-ordered there as well.

Scholarship Committee - The Scholarship Committee has selected seven individuals who will each receive a \$3000 award at the Banquet on July 31 at PYC. Maj Booton has sent all the information about the selectees to LtCol Nelson for the website and will be forwarding emails to the winners notifying them of their selection and providing instruction/information regarding the awards Banquet. The two local ROTC Commanders and their quests will be invited to attend. A call was made to the office of District 01 Florida Representative, the Honorable Jimmy Patronis, requesting his presence at the event but he is otherwise engaged that evening. A substitute from his staff may participate in his place. Maj Booton will be submitting brief biographies of each scholarship recipient as well as a summary of their career aims to the printer for the banquet programs. CAPT Pyle congratulated Maj Booton and his Committee on a job very well done as indicated by the significant increase in scholarship applications received than in the past few years.

### **OLD BUSINESS**

JROTC - President Pyle reiterated the proposal to form a JROTC Fundraising Committee to help raise \$7,000- \$10,000 annually to support the seven high schools in Escambia and Santa Rosa with JROTC programs. He is requesting that a volunteer step up to Chair the Committee and lead the effort. The Treasurer noted that undesignated funds are available to support the programs with awards this Fall but fundraising is needed going forward. During a past Board meeting, a motion was made, and approved by all present, to use the 50/50 raffle monies to support JROTC since scholarship monies are ample. However, the amount collected would not be sufficient to support the units. A proposal was made to present JROTC donations as an option to the members and the Board approved. Members will certainly still be welcome to choose the Scholarship Fund for their donation. **CPT Kirschner** requested that a plaque acknowledging PMOAA's support of the JROTC units be presented to each unit. His request met with approval.

Joint Meeting – PMOAA joined Baldwin and Mobile County Chapters of MOAA on June 19 at The Waterfront Restaurant in Daphne, AL. The speaker was University of South Alabama President, Joshua R. Bonner, who commented on USA's achievement earning the "Military Friendly Gold Standard" as

well as other areas USA's educational excellence impacts the Gulf Coast communities, such as healthcare.

Surviving Spouse Status Discussion – Postponed from the last Board meeting, the topic was discussed and voted on by the Board members present at this meeting. Recent practice had been that a surviving spouse does not inherit the "join date" of the deceased military member, who may have been with MOAA/PMOAA for decades. This practice ignores the surviving spouse's past participation in the Chapter and makes that person ineligible for consideration as an Honorary Life Member in adherence to the By-laws. A motion was proposed to make the "join date" of the military member become the join date of the surviving spouse upon the military member's death. RADM Engel approved the motion and it was seconded by Maj Booton. The motion carried with unanimous approval by the Board.

Honorary Life Membership (HLM) Committee – During the last Board meeting there was discussion and an approved vote on a proposal to dissolve the HLM Committee and grant the Board of Directors discretion to grant lifetime membership to a nominated member. Minor changes were necessary to the official letter to the member notifying him/her of HLM status, and to the phrasing of the By-law change. The changes were completed, discussed, and approved by the Board members at this meeting. The general membership will have the opportunity to vote on the changes at the Business Meeting in November.

Barrancas Memorial Day Ceramony- LTC Vinson-VanHouter represented PMOAA and called the names of those Chapter members on the Taps roster. Quite a few PMOAA members were present at this solemn and poignant event.

Several PMOAA members are also members of Avant Garde and the two separate parties may have contributed to last year's low attendance due to having to choose one group over the other. A motion was made by MAJ Werner to sponsor a joint Christmas event with Avant Garde. The motion was seconded by LTC Vinson-VanHouter. All Board members approved and the motion carried.

**Review of By-laws** – RADM Engel requested that all Board members take some time to read, review, and recommend any changes, particularly on scholarship program issues, in order that the Board have time for discussion and preparation of edits to the By-laws for approval by the general membership at the November business meeting.

### **Membership Meetings**

PMOAA membership will meet again on July 31 at PYC for the Scholarship Awards Banquet from 1730-2000. The menu will include a prime rib carving station. There will not be a membership meeting in August.

The Board of Directors will not meet in July. The next Board meeting is scheduled for August 26 at 1600 at El Patron Mexican Grill.

In September, the dinner meeting will be on the 18<sup>th</sup> at PYC, 1730-2000. The speaker will be Surviving Spouse Committee Chair, Judith Dickson and focus on nutrition and growing your own fruits and vegetables.

President Pyle adjourned the meeting at 1728 hours.
